Water consumption by residential customers for the previous months of October, November, December, January, February, and March provides an average monthly water usage to base sewer charged for the next year. A re-computation is performed in April, changing the rate in May of each year. Before a six month average has been established, a monthly charge of \$30.00 will be used. Commercial and industrial customers will be billed on actual water consumption unless a leveled bill is approved by the utilities general manager. Other billing parameters may be applied and are available for review in the Ordinance(s) establishing the sewer rates.
